- I will use any electronic devices in a public space in my home.
- I will only access 'live' sessions when an adult is with/near me.
- I know that if I break the rules I might not be allowed to use a computer.

### Pupil Responsible Internet Use Agreement (KS2)

I understand that I must use the internet and technology in a responsible way, to ensure that there is no risk to my safety or to the safety and security of the systems and other users. These are the rules I agree to follow when using any digital devices:

#### **For my own personal safety:**

- I will ask permission from an adult before using my devices
- I will keep my username and password safe and secure – I will not share it, nor will I try to use any other person's username and password. I understand that I should not write down or store a password where it is possible that someone may steal it.
- I will only open or delete my own files.
- To protect myself and other pupils, if I see anything I am unhappy with, or receive messages I do not like, I will immediately close the page and tell an adult.
- I will be aware of "stranger danger", when I am communicating on-line.
- I will not disclose or share personal information about myself or others when on-line (this could include names, addresses, email addresses, telephone numbers, age, gender, educational details, financial details etc)
- When I am using the internet to find information, I will check that the information is accurate as I understand that the work of others may not be truthful.
- I understand that the parents/carers/teachers may check my computer files and the sites that I visit.
- I understand that if I deliberately break these rules, I may not be allowed to use the Internet or computers.
- I understand that if I am accessing 'live' sessions online, I need to be in a public space with my parents/carers nearby. I will only access 'live' sessions sent to me by school.

#### **I will act as I expect others to act toward me:**

- I will respect others' work and property and will not access, copy, remove or otherwise alter any other user's files, without the owner's knowledge and permission.
- I will be polite and responsible when I communicate with others, I will not use strong, aggressive or inappropriate language and I appreciate that others may have different opinions.
- I will not take or distribute images of anyone without their permission.
- I understand that if I break these rules, I will be blocked from online platforms.
